# Fall 2016 OCDA Treasurer's Report

- 2016 Summer Conference Report
  - 2016 Summer Conference currently made \$4,600.87 compared to making \$8,964.53 in 2015.
  - Income was impacted by:
    - Grad Credit Fees not yet received
  - Expenses were impacted by several factors
    - Clinician expenses were up
    - Reading Session Accompanist was an unexpected cost
    - Facility fee was unexpectedly less
  - Income and Expense items reflect stability from last year and suggest we are running a conference consistently from year-to-year
  - o Income fell more than expenses did
  - Fee for conference was left the same
- 2016 CHC Report
  - o 2016 CHC made \$2,318.55 compared to making \$1,230.12 in 2015
  - Income was impacted by more ticket sales and greatly reduced registrations (less students)
  - Expenses were up in clinician travel
  - Expenses fell more than income
- 2016 HSHC
  - o 2016 HSHC made \$544.30 compared to making \$3,857.01 in 2015.
  - Expense items increased:
    - Venue Rental was outrageous
    - Clinician lodging issues
    - Accompanist lodging issues
  - The participation level will drive the trajectory of this event in the future.

  - In 2015, we received \$13,602.01 more than we spent and in 2016 YTD, we've received \$5,397.38 more than we spent.

- Thanks to Dara Gillis for chairing today in my absence.
- Thanks, too, to all of our OCDA Board members! Everything you do to promote and drive our tremendous organization is deeply appreciated. OCDA has a strong and secure presence nationally.

#### I – Presidential Concerns:

A). President Elect Rich Schnipke is forming the committee to study re-structuring of the OCDA Board, especially with regards to alignment with the new National R and R structure. He is submitting a report today, and seeking volunteers.

B). Please expect a survey to be issued to all OCDA members. I have written one to gather data about Conference attendance, especially addressing concerns expressed this summer. Tim Cloeter has written one to collect data on the membership's opinions concerning newsletters. It's our intent to issue this survey through the website before the end of this month.

C). The growth of our Summer Conference has created some apparent inequities that we should perhaps address. The accompanist for all sessions was for many years a volunteer who received free registration. Accompanists for honors groups have been paid. There also has been a difference between pay for various clinicians. I would appreciate discussion of this matter. Should OCDA set a pay scale? If so, we could table the issue at this meeting, and vote in the winter meeting (please note, however, that most clinicians for 2017 will already be under contract at that time).

D). Our deepest gratitude to Suzanne Walters for her long service to the Board and her successful development of the Elementary Choir Festivals. Suzanne has stepped aside; we welcome Julie Strebler of Coventry Schools, Summit County to fulfill this position.

E). Board members are respectfully asked to consider submission of articles to the OCDA News an essential and necessary part of their Board position. Dr. Cloeter issues a clear rotational schedule of these submissions. Please do consider writing articles far in advance, to allow time for concept development, editing and proofreading. Waiting for the deadline to write tends to diminish the quality of our publication. At the very least, invite a guest writer for your submission; someone whom you feel can offer valuable ideas or inspirational thoughts to our members. OCDA believes our membership counts on the quality of our *News*; you all have expertise to offer the organization! Thanks, in advance, for taking this duty seriously.

## **OCDA High School Honor Choir Report** Fall Board Meeting 9/10/16

\*2016 Honor Choirs very successful with about 150 participants.

\*Thank you to Frank Bianchi and Lynda Hasseler for their two year commitment as guest conductors and all of their hard work.

\*Ann will be continuing as the HSHC chair with a small committee to help assist with the varies tasks involved. Jared Joseph (Washington Courthouse HS) and Jessica Myers (Licking Valley HS) have agreed to serve on the committee.

\*2017 & 2018 guest conductors will be Gayle Walker and Peter Jarjisian.

\*Gayle Walker and I have been working on getting the choir back at Church of the Messiah. Gayle has contacts with the church and our discussion with the new director of music, John Holsinger, has been positive. Here is our proposal to the church:

1. John Holsinger, Director of Music at Church of the Messiah has positive feelings about hosting the ODDA Summer High School Honor Choir.

2. John plans to talk with the church staff/leaders and explain why the OCDA Honor Choir has positive benefits for the church with regards to a musical relationship with Otterbein and OCDA; he hopes for a positive outcome.

3. During the Honor Choir event, directors Gayle Walker and Peter Jarjisian will reinforce a code of conduct for collegiate section leaders and high school students.

4. The church will not tune pianos beyond the 3 pianos they regularly tune, unless OCDA would like to pay for a tuning.

5. Use of the following rooms are requested. Gayle Walker can work to reserve the Otterbein chapel and one other room in Battelle as needed for sectionals

Sanctuary, Contemporary Worship hall, gym/cafeteria for lunch and dinner, two additional classrooms, the chapel, choir room and green room

6. Custodial hours need to be agreed upon in advance

A simple contract can be drawn up indicating:

- payment to the church \$500 suggested (especially if all the above rooms are used in the church)
- agreed upon room usage
- if there is a need to tune pianos other than the sanctuary, choir room, and McVay Room <u>beyond the sanctuary, choir</u> room, and McVay pianos OCDA would pay for tuning
- Custodial Hours lights will go off at a given hour after the concert or OCDA will pay additional to cover custodian overtime.
- additional trash receptacles in student area (does the church have, should OCDA bring?)
- a basic code of conduct/expectations will be attached to the contract: 1. explaining to students their responsibilities regarding respect for the building; 2. explaining to Honor Choir organizers and section leaders their responsibility as Honor Choir adults/chaperones
- adults will always be in the room with any group of students, supervising

#### 2016 OCDA Summer Conference Report Christopher Dent, committee chair

OCDA's 2016 Summer Conference was held this year June 20–22, on the campus of Otterbein University in Westerville. This year we welcomed Rodney Eichenberger and Andrea Ramsey as our headlining clinicians. Attendance continues to trend down. This year's registration breaks down as follows:

- --Total registration at this year's conference was 138.
- --92 Active Members
- --19 Retired Members
- --13 Student Members
- --11 of those are new or renewing members
- --3 Non-member Spouse
- --31 of those attended for the first time!

We had five student workers from Otterbein who assisted with registration, hospitality, and technology throughout the conference. Only one of the student workers graduated and the remaining four expressed an interest in assisting with the 2017 conference.

The conference boasted seven great performances, including the Ohio Northern University Singers, directed by Dr. Ben Ayling; Lancaster Chorale, directed by Dr. Stephen Caracciolo; Cappricio Columbus, directed by Larry Griffin; and the Dempsey Middle School Choir, directed by Tracy Cinereski.

Lots of publicity went out for the conference again this year including:

This year was the first year that Jill McCullough from Otterbein University served in her role as Director of Summer Conferences (in previous years she was assistant director) and I feel that OCDA and Otterbein can continue to grow and develop a very strong and positive working relationship.

Conference evaluations were positive about most aspects of the event, including clinicians, concerts, social events, etc.

Due to the closing of the Polaris Max and Erma's restaurant in late spring, we were forced to find a new location for the Monday evening Gemutlichkeit. We were fortunate that the Polaris Quaker Steak and Lube was willing to host our social gathering and even provided a room just for OCDA. This year's Gemutlichkeit was very well attended.
